## SEN HEALTH CHECK



#### With the implementation of the Children and Families Act, local authorities need to ensure that their systems are robust and able to meet the new statutory demands.

We can help you to identify areas of weakness through our SEN Health Check. As part of the support we can undertake an audit of your SEN policies and procedures and advise vou on areas where vou may be susceptible to challenge or how existing practices can be strengthened and improved. We also provide follow up work such as drafting policies and arranging specific staff training. The purpose of the Health Check is to build capacity and resilience in SEN Teams and to ultimately improve the quality services offered to families.

### WHAT SUPPORT WE PROVIDE

Every health check is different and depends entirely on the local authority. However, a typical audit may involve the following:

- We will meet with your senior SEN Managers and agree a brief for the audit; we will set a timescale for completing the audit
- We will attend your offices and undertake the audit which may involve:
  - Observing several SEN Panel meetings
  - Considering a random selection of Education, Health & Care Plans
  - Considering a random selection of annual reviews
  - Considering a random selection of case files

- Providing a questionnaire for officers to complete so as to establish the level of SEN awareness
- Liaison with Parent Partnership, which can provide useful feedback on how parents perceive the service
- Considering the number of SEN Appeals and the nature of the appeals
- Liaising with a selected pool of local schools to obtain their feedback on how they perceive the service
- We will prepare a preliminary report setting out our findings and recommendations
- We will undertake any remedial action required on your behalf or provide you with the guidance to do it



### OUR EXPERIENCE

We have experience undertaking a number of SEN Health Checks for a number of authorities, in particular:

- Establishing SEND appeal services for a London Borough and eastern county resulting in better preparation of appeals, legal support for officers and improving outcomes at the tribunal
- Reviewing the SEN panel procedures for a London Borough and suggesting new terms of reference to reduce the bureaucracy of the process and implementing new decision-making procedures to ensure that decisions are taken with legal considerations in mind and recorded more transparently
- Establishing an appeal system for parents to appeal against SEN transport decisions, where the local authority has declined to provide transport for a child with an Education, Health & Care Plan
- Reviewing the specificity and quantification of Education, Health & Care Plans and undertaking staff training so that officers are confidently able to draft Education, Health & Care Plans; this reduced the Council's reliance on external consultants

#### Costs

It is therefore important that decisions are taken with a sound understanding of the legal issues involved and that officers are familiar with the tribunal process and the legal framework.

## SEND CASEWORK PACKAGE

#### **Price on Request**

It is important for local authorities to have access to effective and accessible legal support in order to prepare and defend appeals brought by parents to the Special Educational Needs and Disability Tribunal (SEND). Under this package we will deliver in full or to your own individual requirements your SEN Tribunal Service.

The costs of the support provided will depend on the nature of the specification and the volume of appeals managed. However, the service includes the following as standard:

- Full administration of SEN Tribunals from start to completion, which will include all liaison with schools, professionals, SEN Officers, parents, legal representatives and the Tribunal Service.
- Appointing a dedicated contact for you.
- Creating a dedicated email address for you to send queries to and to deal with all Tribunal administration.
- All correspondence and personal information is managed in accordance with the Data Protection Act.

- We will carry out all preparatory steps required to respond to the appeal. This will involve arranging pre-tribunal meetings, briefing witnesses, arranging further evidence, drafting submissions, preparation of the Tribunal bundle and all Tribunal related liaison.
- Liaising closely with the SEN Team and SEN Management as required throughout the appeal process by attending weekly or monthly review meetings.
- Providing representation at the Tribunal hearing and ensuring that all arrangements are made in advance to support witnesses who have been asked to attend.

The advantage of this package is that it takes away the burden of managing appeals and is managed by SEN specialists. It allows the SEN Team to spend time working with families.

#### Costs

The cost of the service is "fixed" for a year, and we will manage whatever number of appeals arise during the course of the year.

We have managed as few as 15 appeals per year to over 100.

## SEND ADVISORY PACKASE

#### £15,000 (+VAT)

To ensure that local authorities are making the right decisions in respect of their appeals, we offer an advisory service which gives SEN Officers access to legal advice to help answer general SEN queries as and when they require it.

The package comprises of the following support:

- Access to 100 hours of legal advice and support.
- A dedicated and legally qualified and experienced contact who will work closely with you.

#### How Long Do Our Subscription Packages Last?

## INDIVIDUAL TRIBUNAL SUPPORT & REPRESENTATION

(Fixed fee £5,500 + VAT or via an hourly rate)

#### We provide support to local authorities in response to individual SEND appeals.

We offer our clients a fixed fee of £5,500 (+VAT) per appeal. The fixed fee is highly competitive and includes:

- Initial advice on the merits of the appeal
- Attendance at case planning meeting with SEN Officers to discuss the case and what evidence is required.
- Drafting and preparation of documents, including case statements and witness statements.
- Liaising with SEN Officers on the conduct of the appeal and the preparation of evidence i.e. the preparation of expert reports and reports from school.

- Liaising with parental representatives in respect of the appeal.
- Preparation of the Council's evidence.
- Pre-Tribunal meeting with witnesses.
- Representation at the hearing.
- Post hearing written review.
- All travel and expenses.

If the case settles before a final hearing then you will only pay for the work that has been undertaken, which means that in all cases local authorities can budget for the defence of appeals without unexpected costs being incurred.

#### **Support via an Hourly Rate**

Local Authorities/public bodies may decide that they do not wish to engage us via a fixed fee.

We are therefore able to offer an hourly rate of **£200.00** per hour + VAT.

Where a Local Authority/public body requires ongoing legal support and engages our services on an hourly rate, we would provide an initial estimate of costs so that you have some idea of the likely legal cost involved overall in resolving the matter. As the case progresses, we will provide you with regular cost updates to ensure that the costs are manageable and within the budget allocated to the case.



## TRIBUNAL CASE STUDIES

#### Case of "K"

We provided advice and represented the Council in a two-day hearing before the SEN Tribunal. The parents were legally represented throughout and instructed leading counsel for the hearing. The parents were seeking a residential placement for their child which would have significant financial implications for the Council if successful. K's parents were not content with the combination of a specialist day school placement and social care provision that the Council was offering.

The Tribunal dismissed the appeal and upheld the Council's case. As a result of the appeal the Council projected had savings of £1.25 million (costs of child's secondary education, (5 years))

#### Case of "S"

We provided advice and represented the Council in a hearing over three days before the SEN Tribunal. The parents were legally represented. The parents were seeking a home based ABA programme combined with part time school attendance. The Council argued that S's needs could be met in full time education and that the ABA programme was unsuitable, as S had not made progress.

The Tribunal agreed with the Council's case and ordered that S should now attend school on a full-time basis. As a result of the appeal, the Council had projected savings of £300,000 (cost of providing ABA to the end of Year 6).

#### Case of "G"

We provided advice and represented the Council in a one-day hearing before the SEN Tribunal. The parents were legally represented throughout and instructed a leading law firm to provide representation at the hearing. The parents were seeking a residential placement for their child and were requesting autism specific provision. If ordered this would have had significant financial implications for the Council, G's parents were not content with the specialist day school placement the Council was offering.

The Tribunal dismissed the appeal and upheld the Council's case. As a result of the appeal the Council had projected savings of £560,000 (costs of child's secondary education, (5 years)).

#### Case of "M"

We provided advice and represented the Council in a hearing where the parent sought an ABA programme to be delivered in school. The costs of the proposed provision were approximately £50,000 per year. The Council argued that the child concerned did not require a school-based ABA programme and that their needs could be met through an eclectic package of autism support. We provided advice and supported the Local Authority and School in creating the necessary package and adducing the necessary evidence.

The Tribunal dismissed the appeal and found that the Council's proposals for the child's support were suitable and appropriate. As a result of the appeal, the Council saved approximately £250,000 (costs from reception to Year 6 if the ABA provision had been ordered).



## TRAINING

With the implementation of the Children and Families Act and the introduction of Education, Health and Care Plans (EHC), Local Authorities, health services, professionals and educational settings are faced with increasing legal challenges and a need to navigate a complex system.
